Hong Kong Immigration or Hong Kong Skilled Workers Work & Residence Permit, also known as Quality Migrant Admission Scheme. The Scheme is an entrant scheme. **Immigration to Hong Kong** is quota-based and seeks to attract **highly skilled** or talented persons who are fresh entrants not having the right to enter and remain in **Hong Kong** to settle in Hong Kong in order to enhance Hong Kong's economic competitiveness in the global market. Successful applicants are not required to secure an offer of local employment before their entry to Hong Kong for **settlement**. All applicants are required to fulfill a set of prerequisites before they can be awarded points under one of the two points-based tests, namely the **General Points Test** and **Achievement-based Points Test**, and compete for quota allocation with other applicants. Successful applicants under the Scheme may bring their spouse and unmarried dependent children under the age of 18 to Hong Kong provided that they are capable of supporting and accommodating their dependants on their own financial resources without relying on public assistance in **Hong Kong**.

Conditions

In order to be granted a residence permit under the Green card scheme, you must attain **at least 80 points** from **165**.

Age; the applicant must be aged 18 or above when lodging an application under the Scheme.

Financial requirement; The applicant must be able to demonstrate that he/she is capable of supporting and accommodating himself/herself and his/her dependants, if any, on his/her own financial resources without relying on public assistance during his/her stay in Hong Kong.

Good character; the applicant should not have any criminal record or adverse immigration record in Hong Kong or elsewhere.

Language proficiency; The applicant should be proficient in written and spoken Chinese (Putonghua or Cantonese) or English.

Basic educational qualification; the applicant must have a good education background, normally a first degree from a recognized university or a tertiary educational institution. In special circumstances, good technical qualifications, proven professional abilities and/or experience and achievements supported by documentary evidence may be considered. If the applicant fails to provide satisfactory supporting documents showing that he/she meets all the above prerequisites, his/her application will not be processed further and will be refused immediately.

Applicants who are allotted a quota in the selection exercise will be issued with an Approval-in-principle letter through which they are invited to come to Hong Kong to attend an interview in person and submit the original of a certificate of no criminal conviction, or the equivalent, from each country/territory where he/she has lived in for 12 months or longer in the 10 years immediately before the issuing date of the "Approval-in-principle" letter, and produce originals of all documents submitted during the application to the Immigration Department for verification.

Dependants of an applicant are not required to come to Hong Kong to attend the interview. **An Approval-in-principle is not a formal approval of an entry visa/entry permit under the Scheme**

After formal approval is granted, the applicant and his/her dependants, if any, will be issued with an entry visa/entry permit for stay in Hong Kong under the Scheme. The visa/permit label should be affixed onto a blank visa page of the applicant's valid travel document for presentation to an immigration officer upon arrival in Hong Kong.

Family Background (Maximum 20 points)

Maximum 165 Points

To get exemption of IELTS, you have to provide:

1. English Proficiency Letter by University/College.
2. English Proficiency Letter by Employer.

Note: Samples of both letters will be provided to you by CareerCounsel (PVT.) Limited.

Minimum Passing Marks: A minimum passing mark is set under the General Points Test. Interested parties are advised to assess whether their credentials are adequate to meet the minimum passing mark before submitting an application. The minimum passing mark 80. **The prevailing minimum passing mark is 80.**

Attribute Maintenance Funds; (Compulsory)

You must be able to support yourself during your first year in Hong Kong. These amounts **must be held in your personal bank account for a minimum period of 7 days for which you must show bank statements**/other evidence immediately preceding and dated no more than 1 month prior to the date you submit your application. You have to show PKR 10-Lacs Bank Statement for the period of 6-7 Days.

STAGES

Stage 1: Prerequisites

All applicants under the Scheme are required to fulfill a set of prerequisites before they can be awarded points under one of the two points-based tests under the Scheme.

Stage 2: Points-based test

Applicants who have met all the prerequisites may choose to be assessed either under a General Points Test or Achievement-based Points Test. There are five point-scoring factors under the General Points Test and one point-scoring factor under the Achievement-based Points Test.

Stage 3: Approval-in-principle

Applicants who are in the selection exercise will be issued with an Approval-in-principle letter. Such applicants are required to come to Hong Kong to personally attend an interview and present originals of all documents submitted during the application to the Immigration Department for verification. They may enter Hong Kong on visitor conditions for this purpose. **An Approval-in-principle letter issued to an applicant does not automatically guarantee approval of his/her entry to or remain in Hong Kong under the Scheme.**

Stage 4: Issue of entry visa/entry permit

if all original documents are satisfactorily verified and all relevant application procedures are finalized, the successful applicant will be issued with an entry visa/entry permit under the Scheme for stay in Hong Kong.

Application Acknowledgement	An acknowledgement will be mailed to the applicant within one week from receipt of the application
Selection Exercise	Regular basis, may be quarterly
Notice of Selection Result	Result of quota allotment will be published on Immigration Department website within 15 working days after the result of each selection exercise is known
Issuing Approval-in-principle letter	Applicants with quota allotment will be invited to come to Hong Kong within three months for an interview
Issuing Entry Visa/Entry Permit	Successful applicants will normally be issued with entry visas/entry permits within one week following verification of all original documents

Achievement-Based Points Test

The Scheme also caters for the entry of individuals with exceptional talent or skill who have outstanding achievements. They may choose to be assessed under a separate Achievement-based Points Test. Requirement under this test is very high. Assessment under this test focuses on achievements attained by applicants and applicants who opt to be assessed under this test are claiming a scoring of 165 points under one scoring factor only.

Those who are considered to have met one of the criteria under this test listed in the following paragraph will be awarded 165 points; otherwise, no point will be awarded. Applications which fail to score points under this test will be refused immediately.

Points may be awarded under this test if:

- i. the applicant has received an award of exceptional achievement (e.g. Olympic medals, Nobel prize, national/international awards); or
- ii. The applicant can show that his/her work has been acknowledged by his/her peers or has contributed significantly to the development of his/her field (e.g. lifetime achievement award from industry).
